Class descriptions for the 2020-2021 School Year

Regular School Day Options - 8:30 a.m.- 2:30 p.m.

The ECP serves children ages 6 months through age 5

Infant and Toddler Classes:

The Tadpole and Beaver classes meet Monday through Friday. Children have the option of attending a minimum of two days to a maximum of 5 days. Infants and toddlers may choose their days to attend on a first come, first serve basis.

- The **Tadpole** class is for children who are 6 to 12 months old by August 31, 2020. This class has 8 children and 2 teachers.
- The **Beaver** class is for children who are 13 to 24 months old by August 31, 2020. This class has 10 children and 3 teachers.

Preschool Classes:

The Ladybugs, Turtles and Dragonflies meet Monday through Friday. Children have the option of attending a minimum of two days (Tuesday and Thursday), three days (Monday, Wednesday and Friday) or a combination of both classes for a 5-day week.

- The **Ladybug** class is for children who are 2 by August 31, 2020. This class has 12 children and 2 teachers.
- The **Turtle** and **Dragonfly** class is a combined class with children ages 3 to 5 years of age. This class is for children who have turned 3, 4 or 5 by August 31, 2020. This class has a 1:6 ratio for teacher to children.

Aftercare Options - 2:30 p.m.- 5:15 p.m.

We offer an **enrichment hour** or **aftercare** daily. These are open to all age groups. You may attend these anywhere from one day to as many as five days. Enrichment and aftercare are a set schedule; drop-in service is not available. These spots are limited and available on a first come first serve basis.

- **Enrichment** is from 2:30 p.m. - 3:30 p.m. for those families who are looking for a short extension to the regular school day.
- **Aftercare** is from 2:30 p.m. - 5:15 p.m. for those families who need childcare until closing time.

Registration Information

Registration and Supply Fees

- Registration and supply fee payments may be made by check, money order or you may be invoiced through the brightwheel app if you are an existing family with a current account.
- Your non-refundable one time \$60 registration fee is due with each registration. The registration fee is used to cover the cost involved in processing your registration and will hold your child's spot until you receive and complete your enrollment packet.
- The supply fee is \$50 per the number of days attended in a calendar week and paid once yearly.
- Should the ECP be unable to assign your child to a classroom, the supply fee will be returned to you by check within 30 days.
- Supply Fees will not be refunded for changes made by the family after they have been accepted into the program.

Tuition Payments

- Tuition is paid online through the Brightwheel app or by check/money order. **We do not accept cash or credit cards.**
- It is preferred that your Tuition be set up as an automatic withdrawal through Brightwheel. Please note there is a \$.60 processing fee per transaction when using Brightwheel.
- Your first tuition payment is due prior to starting at the ECP with the date due determined by the Administrative Assistant or Director based on your enrollment date.
- Families with more than one child enrolled in the Early Childhood Program will receive a 10% discount off the 2nd child's tuition.

Please read and sign below:

1. I understand that the registration and supply fees must be paid in full and either accompany this registration form with a check or money order, or will be invoiced through the Brightwheel app. I understand that these fees are non-refundable once my child has been placed in the program.
2. I understand that if my child is out of school due to illness, snow days, vacation or for unforeseen circumstances I am still responsible for my full tuition cost.
3. I understand that should it become necessary to withdraw my child from the ECP anytime between registration and the end of the school year, I will be responsible for giving a minimum two weeks' notice. The notice should be received in writing and provide the specific date of my child's last day of attendance. Otherwise, I will still be responsible for the next month's full tuition payment.
